Community Law Project 2014 Year in Review

It has certainly been a big year for the Community Law Project! The Downtown / Lemon Grove project and the City Heights project have started working together so we can better serve our California Western students and the San Diego client community. We have also recently opened up another site in Solana Beach. The Community Law Project now proudly provides clients top-notch legal services in six sites across San Diego County. As our program continues to grow dramatically, we have increased the number of students participating in the legal clinic. The Community Law Project was fortunate to have 26 California Western Students working with our clients during the 2014 calendar year. Over 40 volunteer attorneys, along with our staff, undergraduate administrators, and dedicated law students worked together to serve over 750 individuals through one-on-one legal services and informative community education presentations.

As a program of California Western School of Law, ensuring that the program continues to be a valuable one for our law students is a priority. Our students consistently rate the Community Law Project, and the accompanying clinical course, as a highlight of their law school career.

CLP gave me a unique opportunity to work on a variety of legal issues while interacting with an incredibly diverse community of clients. The experience I gained from interacting directly with clients and working with the attorneys has given me a foundation of skills and knowledge that I rely on every day I as I continue my legal education and look forward to my legal career. In addition to student learning, another measure of an excellent law school legal services program is client satisfaction. The Community Law Project is always striving to improve and expand our services to meet client demand. During the 2014 year, in addition to providing advice, consultations and high qualify referrals to our clients, we successfully launched a pilot project to provide full representation to qualified clients in the area of bankruptcy law. We hope to replicate this project in other substantive legal areas in the months to come. We are also proud to have hosted 12 community education presentations at our sites during the year. These presentations covered a great variety of topics including employment law, disability rights law and estate law, to name a few. Our clients have left these presentations with the knowledge and tools necessary to help resolve their own legal problems.

Finally, our development and fundraising efforts have continued to thrive. We are thankful to Price Philanthropies and the North County Immigration and Citizenship Center for their generous support of our City Heights clinics and Solana Beach clinic respectively.
